3.PLANNING

- Planning Application DA/ 2008/0085: Felines, Brington Lane: erection of steel portal framed agricultural-type building to be used as a garage for two large motor homes.
It was proposed by Mr Bowers, seconded by Miss Swinford and agreed to object to the application on the grounds that it does not fit in with the residential surroundings and is not sympathetic with the majority of the adjacent buildings as suggested by our nearly approved Design Statement.
- WNDC Planning Issues. No decision was made on the best way forward and it was agreed to raise this on the next agenda.

4.CONSIDERATION OF QUOTATIONS FOR SEAT ON THE GREEN

Quotations from four firms were considered and it was agreed to apply for a grant through County Councillor Osborne, for a Westminster seat from "Street Master" in oak.
