Complaints re map on Daventry website, a technical exercise which has caused public confusion, appears to have designated areas for planning, but this is not so. Local Core Strategy is being generated, 2011 is target, Daventry Council still processing planning applications using 'saved' policies from previous strategy documents.</p>
